

## **M&T Bank opens new branch on University of Maryland campus**

### **College Park branch will offer financial literacy education to students**

**College Park, Md., Feb. 25, 2020** — M&T Bank has opened a new, full-service retail bank branch in the Adele H. Stamp Student Union - Center for Campus Life on the campus of the University of Maryland, College Park.

The new branch – located at 3972 Campus Drive in College Park -- will offer the university's faculty, staff and nearly 40,500 undergraduate and graduate students traditional banking services, personal financial education and other financial services. These initiatives are part of the Leadership and Community Service-Learning program at the University of Maryland.
